

## **Santa Photos Giveaway Terms & Conditions ("Conditions of Entry")**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in the Santa Photos Giveaway promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions.
2. The promoter is GPT Management Holdings Limited ABN 67 113 510 188, 631, Level 52, MLC Centre, 19-29 Martin Place, Sydney, NSW 2000, Australia. Ph: 02 8239 3555 ("**Promoter**").
3. This Promotion is open to persons aged 18 years or over who are a resident of the same State/Territory of the Participating Centre respective to their entry.
4. The promotion commences at:

**Wollongong Central** - 9:00am AEST on Thursday 5 November 2020 and ends at 11.59pm AEST on Monday 30 November 2020 ("**Promotional Period**").

**Rouse Hill Town Centre** - 9:00am AEST on Saturday 7 November 2020 and ends at 11.59pm AEST on Monday 30 November 2020 ("**Promotional Period**").

**Charlestown Square** - 9:00am AEST on Saturday 7 November 2020 and ends at 11.59pm AEST on Monday 30 November 2020 ("**Promotional Period**").

**Casuarina Square** - 9:00am AEST (AWST in NT) on Friday 13 November 2020 and ends at 11.59pm AEST on Monday 30 November 2020 ("**Promotional Period**").

Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

  - a) Visit a Participating Shopping Centre's website and follow the prompts to make a booking to have their Santa photos taken at the Centre;
  - b) Attend their booking to have their Santa photo taken; and
  - c) Agree to be entered into the promotion on the day they have their photo taken. By agreeing to go into the promotion the winner also agrees to be added to the relevant centre's email database to receive emails from that centre. Entrants are able to unsubscribe at any time.
7. Valid and eligible entries will be accepted during the Promotional Period.
8. Only one (1) eligible entry per person will be accepted. By completing the entry method, the entrant will receive one (1) entry. For the sake of clarity, a person may complete the entry form for one (1) Participating Centre only in their State/Territory of residence.

11. **Prize Conditions:** - Any ancillary costs associated with redeeming gift cards are not included. Any unused balance of the gift card will not be awarded as cash. Redemption of the gift card is subject to any terms and conditions of the issuer including those specified on the gift card. Exact inclusions in any hamper/pack prize will be determined by the Promoter.

12. **Collection of prizes:** Gift Card prizes can either be collected from the relevant centre or mailed to the winner. Gift Hampers and prize packs must be collected by the winner from the relevant centre.

13. Employees (and their immediate family and/or those living in the same household) of agencies/companies directly associated with the conduct of this Promotion, the Participating Shopping Centres, the Promoter, businesses involved in determination of winner/s for the Promotion, businesses involved in the management of the Promotion, any organisation benefiting from the Promotion, the Promoter's distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

14. **Prize Draws:**

- b) There will be a separate draw conducted for each Participating Shopping Centre, containing entries received via that specific Participating Shopping Centre's Promotion entry page. There will be a total of four (4) draws.
- c) The first valid entry drawn from each Participating Shopping Centre draw will be the winner of the prize specified in the Schedule above for the corresponding Shopping Centre.
- d) The draw conductor may draw additional reserve entries in case an invalid entry or entrant is drawn.

15. The winners will be contacted by email and phone within two (2) business days of the draw. All reasonable attempts will be made to contact each winner.

The winner of any redraw will be notified by email and phone within two (2) business days of the redraw.

The Promoter's privacy policy contains information about how the entrant may access, update and seek correction of the personal information the Promoter holds about them and how the entrant may complain about any potential breach by the Promoter of the Australian Privacy Principles or any other Australian privacy laws and how such complaints will be dealt with. The Promoter collects personal information about entrants to enable them to participate in this Promotion and may disclose the entrants' personal information to third parties including its contractors and agents, prize suppliers and service providers to assist in conducting this Promotion and to the State and Territory lottery departments as required under the relevant lottery legislation. If a prize is provided to the Promoter by a third party, the prize is subject to the terms and conditions of the third party prize supplier and the provision of the prize is the sole responsibility of the third party and not the Promoter. The terms and conditions which apply to the prize at the time it is issued to the winner will prevail over these Conditions of Entry, to the extent of any inconsistency. The Promoter accepts no responsibility or liability for any delay or failure by the third party to deliver the prize, any delay or failure relating to the prize itself or failure by the third party to meet any of its obligations in these Conditions of Entry or otherwise.
27. Any guarantee or warranty given is in addition to any relevant statutory guarantees and warranties and nothing in these Conditions of Entry restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the Competition and Consumer Act 2010 (Cth).
28. If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.

29. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Promoter's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.

The Promoter reserves the right to disqualify entries and entrants in the event of non-compliance with these Conditions of Entry or where the Promoter has reason to believe that the entrant has engaged in unlawful or other improper conduct calculated to jeopardize the fair and proper conduct of the Promotion. In the event that there is a dispute concerning the conduct of the Promotion or claiming a prize, the Promoter will resolve the dispute in direct consultation with the complainant/entrant/winner. If the dispute cannot be resolved the Promoter's decision will be final.

The Promoter, the Shopping Centre owner/s and their associated agencies, related companies, officers, employees and contractors will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or wilful misconduct) in connection with this Promotion or accepting or using any prize (or recommendation), except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

The entrant will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the Promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledges that the Promoter and Shopping Centre may use any such marketing and editorial material without further reference or compensation to them.
33. The Promoter accepts no responsibility for any tax implications and the entrant must seek their own independent financial advice in regards to the tax implications relating to the prize or acceptance of the prize.
