<b>Promotional Period:</b>	<p><b>Start date: 19 February 2026, 9:00am, (AEST)</b>  <b>End date: 28 February 2025, 5:00pm (AEST)</b></p> <p>The promotion period commences on <b>19 February 2026, 9:00am, (AEST)</b>, and ends on <b>28 February 2026, 5:00pm (Promotional Period)</b> and the Promoter reserves the right to extend the promotion end date at any time (subject to regulatory approval).</p>
<b>Eligible entrants:</b>	<p>To be eligible to enter the promotion the entrant must:</p> <ul style="list-style-type: none"> <li>a) Reside in Australia</li> <li>b) Be 18 years or older;</li> <li>c) Reside within a 15km radius from Rouse Hill Town Centre</li> <li>d) Be a member of Rouse Hill Town Centre subject to the terms and conditions which apply to the Membership Program available at <a href="https://www.rhtc.com.au/terms-conditions">https://www.rhtc.com.au/terms-conditions</a> as amended from time to time.</li> </ul>
<b>How to enter:</b>	<p>To enter the Promotion and receive a prize from our prize pool, entrants must complete the following steps during the Promotional Period:</p> <ul style="list-style-type: none"> <li>a) Customers Spend \$100 or more in specialty retail (Appendix A)</li> <li>b) Receipts may be combined over a maximum of 3 receipts for specialty retail but purchases must be made during the promotional period and the day that the customer is claiming a prize.</li> <li>c) The participants present their valid receipts to our Customer Service Desk outside Kmart during operational hours</li> <li>d) Customers scan the QR code to complete the entry form. They are required to fully complete all details including agreeing to sign up to the centre's database and upload their receipt/s. ### Standard Terms

- Nothing in these terms and conditions limits, excludes or modifies or purports to limit, exclude or modify the Promoter's liability in relation to the consumer guarantees under the Australian Consumer Law (Non-Excludable Guarantees). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence) for any personal injury, or any loss or damage (including loss of opportunity) whether direct, indirect, special or consequential, arising in any way out of the promotion including:
